**SUPPLEMENTAL DECLARATION OF

SUPPORT OF PLAINTIFF'S MOTION  
FOR DISTRIBUTION OF CLASS  
SETTLEMENT FUNDS**

1 I, Rochelle J. Teichmiller, declare as follows:

2 1. I am a Project Manager of A.B. Data, Ltd.'s Class Action Administration  
3 Company ("A.B. Data"), whose Corporate Office is located in Milwaukee, Wisconsin. I am over  
4 21 years of age and am not a party to the above-captioned action (the "Action"). The following  
5 statements are based on my personal knowledge and information provided by other A.B. Data  
6 employees working under my supervision, and if called on to do so, I could and would testify  
7 competently thereto.

8 2. The August 5, 2025 Declaration of Rochelle J. Teichmiller in Support of Plaintiff's  
9 Motion for Distribution of Class Settlement Funds (the "Teichmiller Declaration") explained that  
10 A.B. Data has completed processing all 5,409 Claim Forms received through August 5, 2025 and  
11 provided A.B. Data's administrative determinations accepting and rejecting those Claims.<sup>1</sup>

12 3. On August 5, 2025, A.B. Data posted Plaintiff's Motion for Distribution of Class  
13 Settlement Funds and the Teichmiller Declaration to the Settlement Website.

14 4. Since August 5, 2025, A.B. Data has not received any additional claims in the  
15 Settlement.

16 5. The Teichmiller Declaration also explained that Claimants were advised that they  
17 had the right to contest A.B. Data's administrative determination of deficiencies or ineligibility  
18 within twenty (20) days and that they could request that the dispute be submitted to the Court for  
19 review. To date, A.B. Data has not received any requests for Court review.

20 I declare that the foregoing is true and correct to the best of my knowledge.
