- 1. I am a Project Manager of A.B. Data, Ltd.'s Class Action Administration Company ("A.B. Data"), whose Corporate Office is located in Milwaukee, Wisconsin. I am over 21 years of age and am not a party to the above-captioned action (the "Action"). The following statements are based on my personal knowledge and information provided by other A.B. Data employees working under my supervision, and if called on to do so, I could and would testify competently thereto.
- 2. The August 5, 2025 Declaration of Rochelle J. Teichmiller in Support of Plaintiff's Motion for Distribution of Class Settlement Funds (the "Teichmiller Declaration") explained that A.B. Data has completed processing all 5,409 Claim Forms received through August 5, 2025 and provided A.B. Data's administrative determinations accepting and rejecting those Claims.¹
- 3. On August 5, 2025, A.B. Data posted Plaintiff's Motion for Distribution of Class Settlement Funds and the Teichmiller Declaration to the Settlement Website.
- 4. Since August 5, 2025, A.B. Data has not received any additional claims in the Settlement.
- 5. The Teichmiller Declaration also explained that Claimants were advised that they had the right to contest A.B. Data's administrative determination of deficiencies or ineligibility within twenty (20) days and that they could request that the dispute be submitted to the Court for review. To date, A.B. Data has not received any requests for Court review.
